Course Description

This is an advanced course in audio production. It is meant for undergraduate and graduate students with an introductory background in audio and want to further explore audio production. Students will learn basics of capturing and mixing musical performances, setting up sound reinforcement for public address, location audio and postproduction for film and television, including VO, ADR, foley recording, and SFX creation. Creativity and careful execution are major factors in the grading of all projects.

Course Goals

- Reinforce basic audio concepts and terminology.
- Further develop critical listening skills.
- Understanding of gain staging, signal flow and audio reproduction methods.
- Study the different types of analog and digital audio formats.
- Discuss recording studio theories of tracking instruments and how musical sessions work.
- Learn how to mix different musical instruments into a coherent song.
- Practice editing, mixing, and other ways to manipulate audio in Pro Tools.
- Setup a public address system.
- Learn how to, then work on set as a sound mixer, boom operator, and/or sound assistant.
- Understand audio workflows, practices, and standards for mixing television and film.
- Setup and run sessions for voiceover, automatic dialog replacement, & foley.
- How to clean up location audio and other repair practices via Isotope RX
- Basic understanding of surround sound mixing and delivery.

Assignments, Grading, and Due Dates

Production Assignments (60 Points)

Mix A Song: Choose 1 of 5 recording sessions, import the track stems to Pro Tools, and mix the song to stereo. Deliver a .wav and .mp3 files via OneDrive. (10 Points) Due Week 4.

Location Sound: 2 days of working on set as either a mixer, boom op, or audio assistant over the weekends of 3/18-3/19 and 3/25-3/26. (10 points)

ADR/Foley/VO session: schedule and run a session from the available assignments, or come up with one of your own. Students will need to be either an engineer, actor, voice-over or foley artist on the session. (10 points) Due Week

Clean up dialog: Clean up the audio from a crummy location recording using Isotope RX then mix the scene together with natural sounds and music. (10 points)

Mix a scene from Vibrations: Download your assigned interview, import the AAF, organize your session, mix in your cleaned up interview, and deliver 5.1 session with any added audio files to Onedrive. (20 points) Due Week 14

Or Mix the production short: Download your assigned project, Import the AAF, organize your session. Find what's missing and execute as needed: ADR, foley, VO, sfx creation, music selection. Mix and deliver 5.1 session back to project folder. (20 points) Due Week 14

Or Mix another short: Find project (yours, another students, etc.), Import the AAF, organize your session. Find what's missing and execute as needed: ADR, foley, VO, sfx creation, music selection. Mix and deliver 5.1 session back to project folder. (20 points) Due Week 14

Policies and Expectations

Policy on Late Work: Late work will not be accepted. It will receive a zero. You are allowed to redo most projects if they are turned in on time. There will be no makeup exams.

Policy on Absences: Attendance is crucial. We will be covering a large amount of information and work each session. Since this is a production class that meets only once a week, if you are to miss more than two classes without a reasonable excuse (illness, family emergency, etc.) you will receive one letter grade reduction on your final grade. Any further absences will equal a full grade reduction per missed class. It is the responsibility of the student to acquire notes or materials for any missed class.

Rough Cuts: The days we go over rough cuts are for you. They are meant to help you complete the best possible project with the peer feedback you receive. They are <u>mandatory for the Sound Design and Final Project</u>.

Redoing Projects: You are almost always allowed to redo any project for a better grade, barring the final project or the mid-term. <u>Please check with me before you do this</u>.

School of Communication Statement on Academic Integrity

A basic mission of a university is to search for and to communicate truth as it is honestly perceived. A genuine learning community cannot exist unless this demanding standard is a fundamental tenet of the intellectual life of the community. Students of Loyola University Chicago are expected to know, to respect, and to practice this standard of personal honesty.

Academic dishonesty can take several forms, including, but not limited to cheating, plagiarism, copying another student's work, and submitting false documents. These examples of academic dishonesty apply to both individual and group assignments. Academic cheating is a serious act that violates academic integrity. Cheating includes, but is not limited to, such acts as:

- Obtaining, distributing, or communicating examination materials prior to the scheduled examination without the consent of the teacher;
- Providing information to another student during an examination;
- Obtaining information from another student or any other person during an examination;
- Using any material or equipment during an examination without consent of the instructor, or in a manner which is not authorized by the instructor;
- Attempting to change answers after the examination has been submitted;
- Taking an examination by proxy. Taking or attempting to take an exam for someone else is a violation by both the student enrolled in the course and the proxy.
- Unauthorized collaboration, or the use in whole or part of another student's work, on homework, lab reports, programming assignments, and any other course work which is completed outside of the classroom;
- Falsifying medical or other documents to petition for excused absences or extensions of deadlines; or
- Any other action that, by omission or commission, compromises the integrity of the academic evaluation process.

Plagiarism is a serious violation of the standards of academic honesty. Plagiarism is the appropriation of ideas, language, work, or intellectual property of another, either by intent or by negligence, without sufficient public acknowledgement and appropriate citation that the material is not one's own. It is true that every thought probably has been influenced to some degree by the thoughts and actions of others. Such influences can be thought of as affecting the ways we see things and express all thoughts. Plagiarism, however, involves the taking and use of specific words and ideas of others without proper acknowledgement of the sources, and includes, but is not limited to, the following:

- Submitting as one's own material copied from a published source, such as Internet, print, CD-ROM, audio, video, etc.;
- Submitting as one's own another person's unpublished work or examination material;
- Allowing another or paying another to write or research a paper for one's own benefit; or
- Purchasing, acquiring, and using for course credit a pre-written paper.
- Submitting the same work for credit in two or more classes, even if the classes are taken in different semesters. If a student plans to submit work with similar or overlapping content for credit in two or more classes, the student should consult with all instructors prior to submission of the work to make certain that such submission will not violate this standard.

The above list is in no way intended to be exhaustive. Students should be guided by the principle that it is of utmost importance to give proper recognition to all sources. To do so is both an act of personal, professional courtesy and of intellectual honesty. Any failure to do so, whether by intent or by neglect, whether by omission or commission, is an act of plagiarism. Plagiarism or any other act of academic dishonesty will result minimally in the instructor's assigning the grade of "F" for the assignment or examination. The instructor may impose a more severe sanction, including a grade of "F" in the course. All instances of academic dishonesty must be reported by the instructor to the Associate and Assistant Deans of the School of Communication. Instructors must provide the appropriate information and documentation when they suspect an instance of academic misconduct has occurred. The instructor must also notify the student of their findings and sanction.

The Associate and Assistant Deans of the School of Communication may constitute a hearing board to consider the imposition of sanctions in addition to those imposed by the instructor, including a recommendation of expulsion, depending on the seriousness of the misconduct. In the case of multiple instances of academic dishonesty, the Dean's office may convene a separate hearing board to review these instances. The student has the right to appeal the decision of the hearing board to the Dean of SOC. If the student is not a member of the SOC, the dean of the college in which the student is enrolled shall be part of the process. Students have the right to appeal the decision of any hearing board and the decision of the two schools will review the appeal together. Their decision is final in all cases except expulsion. The sanction of expulsion for academic dishonesty may be imposed only by the Provost upon recommendation of the dean or deans.

Students have a right to appeal any finding of academic dishonesty against them. The procedure for such an appeal can be found at:
