**Biographical Sketch**

The Rev. Stewart E. Dollard was born in Chicago September 14, 1905. He joined the Society of Jesus in 1925 and entered St. Louis University to study philosophy, earning a bachelor's degree in 1929, a master's in 1930, and a Ph.D in 1934. He completed his theological studies at St. Mary's, Kansas, and was ordained a priest in 1937.

After his ordination, Fr. Dollard taught philosophy at West Baden College and in 1941 was appointed Dean of the Philosophate there. In 1946 he was appointed Dean of the Graduate School at Loyola University of Chicago. During his years at Loyola, Fr. Dollard chaired the Budget Committee and the Committee on Faculty Appointments. He was secretary of the Board of Trustees for fifteen years. Fr. Dollard died December 9, 1975, at the Monticello Rest Home, Oak Lawn, Illinois.

**Scope and Content**

The Stewart E. Dollard, S.J., records comprise 1 linear foot spanning the years 1941 through 1957 and includes correspondence, memos, reports, proposals, and by-laws. Some records were generated by Fr. Dollard's predecessor, Francis Gerst.
