

Dana Harmon, PhD, Clinical Instructor and Director of and her coauthors received the8th Annual Florence W. Vigilante Award for Scholarly Excellence in recognition of the best article published in Volume 39 (2019) of the Journal of Teaching in Social Work. The article, The Dehumanization of Black Males by Police: Teaching Social Justice-Black Life Really Does Matter! The authors discuss the history of police oppression

and killing of Black males and offer critical race theory as a theoretical perspective that helps to explain this pervasive social inequity. More important, the authors provide practical classroom narratives, assignments, and strategies that may hold promise in addressing the problem of police brutality and the killing of Black males. The award is given annually in honor of the founding editor of the Journal to recognize outstanding scholarship and creativity.

### **Engaging Students in Mental Health Services in Migration Crisis Situations**



Social Work faculty members Maria Vidal de Haymes, Mauricio Cifuentes and Alejandro Olayo-Méndez from Boston College received a grant from the Council on Social Work Education's Katherine A. Kendall Institute for International Social Work Education. The 3-year project, A Curriculum and Internship Model for Socioemotional Care and Mental Health Services in Migration Crisis Situations. will develop, pilot, evaluate, and disseminate a professional internship model and curriculum designed to prepare social work

students for interprofessional practice in migration crisis situations. The project will serve asylum seekers confined to the U.S.'s Mexican border due to the recent implementation of the Migrant Protection Protocol policy of the U.S. government.



# Singer invited to White House PREVENTS meeting; tells Chicago Tribune that coronavirus pandemic suicide risk 'Could last years'




In his role as president of the Washington D.C.-based American Association of Suicidology, Associate Professor Jonathan Singer was invited to take part in the President's Roadmap to Empower Veterans and End a National Tragedy of Suicide (PREVENTS) this past year. The group met in the White House Secretary of War Suite (shown in photo), where Singer led the first hour morning discussion about the role social work could and should play in suicide prevention. In April, Chicago Tribune reporter Kate Thayer interviewed Jonathan about COVID-19 and suicide risk. After years of a steady climb in suicide deaths, prevention advocates worry there could be a mental health fallout from the coronavirus pandemic for years to come. Consequences of the COVID-19 pandemic are also

risk factors for suicide, experts say, including prolonged isolation, a down economy with massive job losses, and an uptick in domestic violence that could lead to more suicides in the coming months, or even years. Suicide expert Singer added "We've never been through this before, so we don't actually know, but there are things that concern me," he said, adding that studies show much of what the public is experiencing correlates with higher suicide death rates.

## Harnessing the Power of Low-Income Fathers to Have a Positive Impact on Society



Power of Fathers (PoF) is an innovative collaboration of four social service agencies focused on improving outcomes for children by improving the life circumstances of their fathers. The initiative was created in response to broader social issues addressing fathers' challenges on the individual, organizational and systems level. On the individual level, PoF works to address fathers' specific challenges/barriers to improving their lives and supports them in improving their parenting and co-



parenting skills and relationships with their children and the mothers of their children. At the organizational level, the focus is on improving policies, practices, and programs that work with fathers and families, first internally, and then to use the findings to inform other agencies and organizations in the community. Lastly, the policy/systems level focuses on addressing the policies and systems that adversely impact fathers' ability to positively engage with their families and communities.



Dara Lewis, PhD, Research Associate with the Loyola University School of Social Work's Center for Research on Self-Sufficiency (CROSS) noted that "Ed Davies, PoF Director indicated 'After the first year of the program, several key programming and structural changes were made to improve implementation.' The largest program adjustment was made to the curriculum based on feedback fathers shared that it was hard to focus on improving their parenting and co-parenting skills while in the program when they were also dealing with many individual personal issues."

Addressing the fathers' concerns, PoF collaborated with the research team (CROSS) at Loyola University Chicago to integrate the Transforming Impossible to Possible (TIP\*) model, an evidence-based, transformative social work group model with their fatherhood specific content curriculum. The addition of TIP\* greatly improved fathers' experiences in the program as well as retention. To further support the PoF program, CROSS developed TIP\* for Fatherhood with, an adapted version of TIP\* designed to strengthen psychological self-sufficiency (PSS) related to fatherhood. PSS related to fatherhood involves transforming fatherhood barriers into fatherhood hope in order to achieve goals as a father and coparent.

## Addressing Health Disparities through Community Action & Advocacy



Social work PhD student, Tony Johnson is a clinical researcher who blends his longstanding community involvement and advocacy to address racial health disparities. Tony was recently interviewed as part of a Washington Post article on addressing the uptake of Black and Hispanic communities in COVID-19 vaccine trials (7/26/2020). Tony, who has been involved in the early stages of COVID-19 vaccine development, noted that "It's about education...I need to have a concrete plan for [recruitment diverse communities for COVID-19 vaccine trials]. They're interested. They're nervous. A whole lot of them have

been impacted by COVID-19 in different ways". As a community advocate, Tony attends events across the city of Chicago as an essential part of his work in clinical research for addressing racial disparities. Tony is shown the picture above (on the right) with his partner Quintin Cammack, both are wearing shirts that includes that James Baldwin quote "The place in which I'll fit will not exist until I make it". As



Tony has a special interested in building community resilience, he continues to partner with organizations such as the Black Treatment Advocate Network, Chicago's Black Gay Men's Caucus and Illinois PrEP Working Group. Tony currently proudly serves as the Centers for Disease Control and Prevention (CDC) Ambassador for the Let's Stop HIV Together Campaign in Chicago.

#### First Star Youth Pivot for a Most Unique Summer Program



Since 2015 and funded by gifts from donors and a grant from the Illinois Department of Children and Family Services, Loyola University Chicago's First Star Academy transforms the lives of foster youth, ensuring they have the resources and

supports to thrive in school and successfully transition to adulthood. The year-round program features monthly meetings during the academic year, and an intensive summer experience. Peer- and staff- mentoring, with training and support are also provided by PI and Social Work Professor Julia Pryce, PhD and her Co-PI Social Work Professor Philip Hong, PhD. The program works



to support students' academic achievement and personal development, and promote the realization of each student's personal, educational and career goals, specifically high school graduation and college success.



Bridget Couture, PhD, Co-PI and Program Director noted that "This summer was certainly a unique experience for First Star at Loyola. We traded in our residential summer academy for a virtual program". First Star youth connected through comedy in improv classes (through Chicago's Second City), Zoom book clubs, Zoom lunch dates (with food delivered to each kid at home), as well

as virtual fitness classes, embroidery lessons, and

online games and movies. Couture added "The highlight for the youth was the time we were able to spend in person, through a partnership with Chicago Voyagers, an affiliate of Trips for Kids that offers programs to inspire healthy lifestyles and instill environmental values. The kids loved being together, getting out of their homes and neighborhoods and into nature, as well as learning new skills. They were able to hike together at Starved Rock, canoe on local rivers and cycle on bike trails.





### **CENTERS, INSTITUTES & TRAINING PROGRAMS**

The School of Social Work faculty and students engage in innovative and practice-informed research, scholarship and evidence-based training across a range of disciplines through institutes, centers, and training programs to support Ignatian traditions of social responsibility and justice.

#### **BRAVE - Building Resilience Against Violence Engagement**

<u>BRAVE</u> is a collaborative effort of social work, psychology, and child welfare researchers based out of Loyola University Chicago School of Social Work focused on developing culturally appropriate youth violence prevention manuals that can be reproduced and implemented in minority communities. Dr. Caleb Kim is PI of the grant that funds BRAVE; Drs. Rana Hong and Terri Kilbane are Co-PIs.

# C-FIRST – Center for Field Innovation, Research, Strategy, and Training

C-FIRST engages community-based interventions and practice-based research that supports the sustainable implementation of innovative interventions to meet the unique challenges faced by organizations, clinicians, and students across Chicago and suburban communities. Drs. Michael Dentato and John Orwat serve as Co-Directors.

#### **CIRA – Center for Immigrant & Refugee Accompaniment**

The Center for Immigrant and Refugee Accompaniment (CIRA) is a new initiative of the School of Social Work to support the formation of social work professionals that in solidarity can accompany migrants in the construction of a more inclusive local and global community that affirms the human dignity of the person. Dr. Maria Vidal de Haymes directs CIRA.

#### **CROSS - Center for Research on Self-Sufficiency**

The Center for Research on Self-Sufficiency (CROSS) is a fully grant funded community-engaged research center at Loyola University Chicago's School of Social Work. CROSS examines long-range solutions to the issue of self-sufficiency in diverse communities through community engagement using education, practice, and research on psychological self-sufficiency (PSS) as a vehicle. PSS theory and TIP® model are being applied and investigated in the areas of workforce development, educational empowerment, family strengthening and fatherhood, health and mental health promotion, financial capability, youth engagement, violence prevention, and productive aging. CROSS has been funded by the Lloyd A. Fry Foundation for 5 consecutive years to support community partners with training and capacity building with the TIP Institute as a community engagement arm of CROSS. Dr. Philip Hong is Director of CROSS.



#### **ECP - The Empowering Counseling Program**

The Empowering Counseling Program (ECP) partners with schools, residents, churches, and social service providers throughout Chicago to provide school-based clinical social work services to disadvantaged youth who might not otherwise receive counseling or support. Counseling services of the ECP are designed and implemented through a street-based social work framework. Currently funded by After School Matters the program facilitates a participatory, rights-based, psycho-educational after school program designed to build resistance and resilience against oppressive social conditions. The ECP also conducts individual to family counseling based on a street-based social work framework. Dr. Katherine Tyson McCrea is ECP Founder and Principal Investigator.

#### **FSPP - Family & School Partnership Program**

The Family and School Partnership Program (FSPP) was launched in 1996 to provide post-master's training and consultation to school social workers and other school mental health professionals. The FSPP has trained over 800 school social workers/school mental health professionals through the Annual Summer Institutes and bi-monthly Consultation Groups. Dr. Michael Kelly is Director of FSPP.

#### **OWETP@LUC-The Opioid Workforce Expansion Training Program**

OWETP@LUC is a federally funded grant program that aims to enhance prevention, education, treatment and recovery of adolescents and transitional-age youth (individuals up to 26 years-old) at high risk for substance use disorder (SUD) and opioid use disorder (OUD) by creating a pipeline to employment.

# SBIRT@LUC – Screening, Brief Intervention, and Referral to Treatment Training Program

SBIRT@LUC is a collaborative interprofessional training program involving the School of Social Work, Marcella Niehoff School of Nursing and Stritch School of Medicine. The program trains students, faculty and community-based professionals on the SBIRT (Screening, Brief Intervention, and Referral to Treatment) model and motivational interviewing techniques through classroom and community-based settings across Chicago. Funded by the Substance Abuse and Mental Health Services Administration (SAMHSA), it is an effort to reduce the impact of substance abuse and mental illness upon marginalized communities, most especially racial/ethnic and LGBTQ populations. Drs. Michael Dentato and John Orwat are SBIRT@LUC Co-Directors. ,



### STUDENT-ENGAGED RESEARCH & SCHOLARSHIP

Many social work students engage in research and scholarly activities at Loyola. Faculty mentors provide opportunities for undergraduate and graduate students in innovative practice-informed, human-centered and empowerment-based research and scholarship that engages our clients, community partners and collaborators. Social Work faculty are recognized as leaders in mentoring students in research and scholarship. Student involvement in research and scholarly activity in social work deepens the academic experience and exemplifies Loyola's Jesuit mission to expand knowledge in the service of humanity. Peer-reviewed publications and juried presentations in 2019-2020 that include students as coauthors are included below.

#### Students Active in Communicating Research and Scholarship

**Over 55** student coauthors

80% of social work faculty engaged with students on peer-

reviewed <u>publications</u> and juried <u>posters/presentations</u>

Social work faculty at Loyola University Chicago actively involve students in research and scholarship, including publication and presentation. In 2019-20, social work faculty engaged over 55 students as coauthors on peer-reviewed journal publication and juried posters or oral presentations at conferences. Students included BSW, MSW, PhD students in the School of Social Work, students enrolled in programs

in other LUC Schools, as well as students from The University of Georgia, University of Pennsylvania, and The University of Toronto. Eighty percent of social work faculty included students in communicating outcomes of research and scholarship as coauthors on peer-reviewed publications and/or juried presentations during 2019-2020. Health Watson, LCSW and doctoral student, reflected on her involvement in publishing with her mentor, Katherine Tyson McCrea, PhD, Professor and PI, Empowering Counseling Program. "I appreciate the focus on the duality of practice-informed research and research-informed practice as I develop my skills as a researcher...Dr. Tyson allows room for growth and improvement while also providing a safety net so I am comfortable as a beginning researcher. Dr. Tyson also has provided excellent mentorship and enabled me to gain experience as a peer reviewer for American Psychologist. This experience has really exposed me to the nuts and bolts of publishing research and gives me confidence as I move forward in my career." Doctoral Student Johanna Barry, LCSW, also noted that "....faculty are incredibly generous and inclusive when it comes to sharing opportunities for publications and conference presentations with their students. I was thankful to be included in eight research studies during my time at Loyola, all of which gave me the opportunity to learn about the publication process, discern the processes involved in grant-funded research, and work with a collaborative, often interdisciplinary research team. I was consistently treated as a colleague and equal...faculty members would take the time to introduce me to other instructors at different universities. All publications and conference presentation opportunities required a great deal of work, my wonderful



mentors ensured I felt prepared and supported during these processes. I am deeply grateful for this aspect of my experience at Loyola."

# **Dentato Receives 2020 Langerbeck Undergraduate Research Mentoring Award**



The 2020 Langerbeck Award for Undergraduate Research Mentoring has been awarded to Michael Dentato, PhD, Associate Professor in the School of Social Work as part of the Loyola Undergraduate Research Opportunities Program Annual

Center for Experiential Learning 2020 Undergraduate Research and Engagement Symposium, held virtually in April. The Langerbeck Award is a University-wide award given to a faculty member who shows extraordinary success in providing intensive individual research experiences for undergraduate students and is sponsored by Center for Experiential Learning and Faculty Center for Ignatian Pedagogy.

## Social Work Students and Faculty Adapt to Present at Virtual IASWG Meeting



Loyola is one of only two MSW programs in the country with a focus on group work and has a local, national, and international reputation for group work education. Eight Loyola faculty, including Shirley Simon,

Associate Professor and Director of the MSW Program's Sub-specialization in Group Work, worked with students who had 15 student posters and oral presentations accepted for the virtual meeting, held in June, 2020. Since its launch in 2018, over 50 students have enrolled in the MSW Program's <u>Sub-Specialization in Group Work</u>. In a recent survey, two thirds of employer/respondents looked for social workers with skills in group work and over 80% offered services that included groups.





### **NEW FACULTY JOIN SCHOOL OF SOCIAL WORK**



Dana K. Harmon, PhD, MSW, Coordinator – MA Public Service Leadership, Accreditation Specialist and Instructor

Dr. Dana K. Harmon joined the School of Social Work in July 2020. She earned her PhD from the University of Alabama, her Masters of Social Work from Loyola University Chicago, and Bachelor of Arts from the University of Alabama. She is a member of Phi Beta Kappa Honor Society and is a Southern Regional Education Board (SREB) Graduate Scholar. Additionally, she is a Licensed Independent Clinical Social Worker. Dr. Harmon has also been an accreditation specialist at the Council of Social Work Education (CSWE), in

which she provided technical assistance and consultation to BSW and MSW programs. She has done research, published, and presented at local and national conferences particularly related to Black/African American males and families. As a social work educator, Dr. Harmon views teaching as an opportunity to inspire, empower, and enhance student learning as a transformative experience. She embraces the idea that understanding systemic racism, discrimination and social justice, is multi-systemic and multi-dimensional, as well as beneficial, when teaching across the social work curriculum and for program development. As a social work practitioner, she believes each person has the strength and skills to search out and implement solutions for healing and growth, which can transform their life.



Rana Hong, PhD, LCSW, RPT-S, Research Assistant Professor

Dr. Rana Hong was appointed as a Research Assistant Professor in January, 2020. She is a methodologically grounded clinical researcher and educator who brings to Loyola great expertise. For the past 20 years, she has helped over a thousand children, adolescents, and families who suffered from issues of attachment, trauma, and emotional/behavioral disturbances. In her journey of exploring and validating healing factors for vulnerable children and adolescents, she joined Center for Research on Self-Sufficiency at Loyola as a

senior research associate in 2016, where she enhanced her research with neurobiology, theoretical analyses, metric development, and program evaluation. Notably, she has published 16 articles in peer-reviewed journals and book chapters and co-edited the forthcoming book of Theraplay application and implementation (2020). She has also taught clinical practice courses at the Master level at Loyola since 2012. Dr. Hong earned her PhD from Loyola University Chicago, Masters of Social Work from University of Illinois at Chicago, and Bachelor of Arts from Sookmyung Women's University in Seoul, Korea. As a leading play therapy trainer locally and internationally, Dr. Hong holds many rigorous certifications in evidence-based models: She is registered play therapy supervisor and provider, certified Theraplay therapist/ supervisor/ trainer, certified Eye movement Desensitization and Reprocessing (EMDR) therapist, and certified Parent-Child Interaction Therapy (PCIT) therapist/level 1 trainer.



Lastly, Dr. Hong serves as the President of the board at an international agency, The Theraplay Institute, as part of her community service commitment.



#### Abha Rai, PhD, MSW, Assistant Professor

Dr. Rai joined Loyola in July, 2020. She comes with over a decade of international community work experience. She has worked closely with community-based organizations while designing programs, engaging in program evaluation and providing direct support to individuals, families and groups. Dr. Rai has been a grassroots community worker in both rural and urban India. She has led national campaigns across India in partnership with multinationals and agencies like Johnson & Johnson, ANZ Bank as well as the

US Consulate. She has also worked with community organizations in the Chicago area for about two years now. Through her community experience, Dr. Rai has engaged both in micro and macro social work practice. Dr. Rai earned her Bachelor in Academic Law and Master of Social Work degrees from India. She received her Doctorate in Philosophy from the School of Social Work, University of Georgia. Her research interest is informed by her passion for engaging in community-centered research. Her primary areas of interest include gender-based violence across communities, with a specific focus on immigrants and immigration issues. Dr. Rai is invested in mentoring and aims to create "significant learning experiences" for her students. She has previously taught both undergraduate and graduate-level courses. Her research and practice expertise directly inform her classroom approach and discussions. As a scholar, educator and practitioner, Dr. Rai strives to further social justice every step of the way.


