## RESEARCH FOCUS

My research has focused on evaluation of programs and interventions affecting urban communities and impoverished populations. A central focus is the **intersection of personal and systemic factors that relate to service use and influence the effectiveness of intervention**. This has remained a focus in primarily two main areas; **assessment of services to victims of sexual and family violence and services to homeless and impoverished individuals**. My foci have emphasized the organization of services as well as community and individual factors that facilitate or impede service use and effectiveness. My approach to evaluation has primarily involved large empirical studies and quantitative analysis, although more recently, I have begun to engage in more qualitative work.
